Research papers can be submitted only by the Life / Annual members of AET. A member can submit and present a maximum of two research papers. Each research paper can have a maximum of two authors. Each authors has to register separately. Authors submitting more than one paper have to register separately for each of the papers. Only single author papers presented at the conference will be considered for Best Paper Presentation Award.

The Guidelines for Paper-Presenters

- A paper should have a Title, Author's Name, Institution, Contact (Residence) Postal Address, Cell Number and Aadhar Number including email address.
- Papers should be neatly typed (double space) in Times New Roman, font size 12 in A4 bond paper.
- A Paper should not exceed six typed pages.
- A member can present a maximum of two papers only
- In case of joint authors, only the first two names will be considered.
- Only single author papers presented at the Annual Conference will be considered for paper presentation award.
- An abstract of the paper to be presented at the AET Conference, along with the Delegate Fee of Rs. 340/- (for all) , should be sent to the AET Conference Secretary, **Dr.M.Ponnaiah**, Associate Professor & Dean of Research & HOD, PG & Research Centre of Commerce, G.T.N Arts College (Autonomous), Dindigul – 624005 , by Wednesday, 20th November 2024 at 44aetconferences@gmail.com.
